Good Morning! We have the following items on the July 5, 2007 meeting Agenda:

- ▶ **Suvi Inc, 419 River Street - Window Signs. Request for two window signs 17.3" x 27.2".**
Approval was received for the installation of a temporary sign on June 12, 2007. The applicant already had their signs made and has installed one of the signs as a temporary sign. They were told that if the Commission did not approve the sign it would need to be removed.
- ▶ **Port City Grille, 318 River Street - Window Sign. Request for one window sign**
Approval was received for the installation of a temporary sign on June 12, 2007. The Application form for temporary signs had not been finalized when the request for a temporary sign was approved. The applicant did not supply dimensions. The temporary sign approved is larger than 16 square feet. The application for temporary signs includes dimensional standards and by signing the application the applicant agrees to comply with the standards.
- ▶ **Northern Spirits LLC, 389 River Street - Exterior Alterations/Paint Removal.**




Pictures of 419 River Street. Proposed sign has been installed in lower portion of right window as a Temporary Sign.







The meeting is held the first Thursday of the month at 3:00 p.m. at the Manistee County Historical Museum, 425 River Street, Manistee, Michigan unless it is a legal holiday. Applicants are strongly encouraged to conduct a preliminary discussion with staff and attend the meeting to explain the proposed work.

The following information should be included with this application. Additional information may be required. The applicant must supply 10 copies of any items submitted that are in color.

- ▶ Current photo of the structure as seen from the street and where proposed work is to take place.
- ▶ Sketch, drawing or plans and/or elevations of proposed work scaled proportionally. Provide dimensions. Indicate where this work is in relation to the main structure.
- ▶ Drawings to show details and specification of ornamental features.
- ▶ Where appropriate, plans showing property lines for fencing, projected view of structure for signs, perspective drawings for new additions.
- ▶ If changing paint colors you must provide; brand name of paint, paint color name, paint color numbers, paint color chips and a paint plan for the building showing the proposed work.


