**440.01 ONE-WAY STREETS**

One-way streets, and the direction of traffic thereon, are hereby designated as follows:

- A. Tamarack Street                      One way South to North between 4<sup>th</sup> and 3<sup>rd</sup>
- B. River Street                            One way East to West between Division and Water Street
- C. Third Street                             One way West to East between Tamarack and Cedar
- D. Short Street                             One way North to South between 5th and 6th
- E. Sixth Avenue                          One way East to West between Short and Ford
- F. Fairview Avenue                      One way South to North between Eighth and Fifth

**440.03 USE OF MOTOR VEHICLES IN POSTED PUBLIC AREAS; EXCEPTIONS**

No motor vehicle, as defined in the Uniform Traffic Code, as adopted in Section 410.01, licensed or unlicensed, shall be operated in any posted public areas in the City, except on roads that are maintained for the purpose of travel by motor vehicles. Said posting shall be consistent with the use of said areas. No operator of a motor vehicle, licensed or not, shall make an entrance or exit within the posted areas in the City. The exception, however, shall be vehicles which are used in the maintenance of recreation and beach areas. (Ord. Unno. Passed 8-2-83.)
