Q15:	In general, the recreation planning process is not paying attention to water resources. Manistee County is 57% water in area. Lake Michigan beaches, local lakes, the Manistee River, and its tributaries, are a major recreation resource. The trails system within Manistee County is popular largely because of its proximity to water. I suggest that a Manistee County Recreation plan must intentionally incorporate the water resources. Another recreation resource in the county is Agritourism. I suggest that Agritourism should actually be considered a part of a trails system. In summer months, it is common to see motorists touring local farms (U- pick farms) and small markets. Recently, we have begun to see bicyclists touring farm markets. So, I hope the plan can pay some attention to farms and Agritourism, and make water resources a part of the plan.

The Village of Kaleva’s Village President and the Village Trustees have the ultimate authority over the jurisdictions parks and recreation as the Village does not have a parks and recreation department. The Village council also has the authority to commit funds, accept grants, and purchase land. The current year and projected annual budgets for the Village of Kaleva’s parks and recreation consist of operation and maintenance, \$16,000; recreation programing, \$4,000 for Kaleva Days, \$0 for their Softball Tournament, \$2,000 for August concerts; and capital improvement, \$3,500 for the repair of their softball concession stand. The source of the Village’s funding for their parks and recreation comes from the general fund, campground fees, pavilion rentals, and contributions for concerts. The Village of Kaleva currently has 40 volunteers who staff their parks and recreation programs by planning and booking concerts, coordinating and scheduling the use of softball fields, and planning the Kaleva Days celebration. The Village currently does not have a relationship with the local school districts, however the Village does have relationships with other private organizations consisting of informal agreements with local Lions Club, the local fireman’s association, and the local Historical Society. The Firemen and Lions Club puts on Kaleva Day’s and the Historical Society puts on the concerts. The Village also works directly with the Manistee County Planning Department.
